Important Dates To Save

March 16th @ 7 pm - General Membership Meeting May 18th @ 7 pm - Annual Board Elections

The world has come a long way in the past 12 months, but we are still living in unusual times and we are all doing everything we can to protect our own health and the health of our neighbors. These concerns along with mandated safety procedures required us to take a different approach to holding our annual meeting and elections last year, and this year is no different.

There will be two options for attending this years General Membership meeting. The first option is to attend the meeting at the theater. All social distancing guidelines will be strictly enforced and masks will be required. Option two is to attend the meeting virtually from the comfort of your own home. A link to the live feed will be emailed to all members a few days before our meeting along with instructions on how to follow it.

Among the many topics we will be discussing are

- 1) May Board Elections There are three seats on the board up for election. We will be using "Election Buddy" again this year. Charlie Rader is heading up this years Nomination Committee and will be asking for three volunteers to fill the committee.
- 2) **Loveland's Amazing Race** What type of "stop" we will have this year as well as asking for volunteers to staff the event.
- 3) Membership Gregory Smith is our new membership chair. Dues this year are \$ 15.00 per individual and \$ 25.00 per couple. Both people in a couple must fill out separate membership forms with separate email addresses. Election Buddy sends one and only one ballot to each email address. The link to pay your dues online is Membership-Loveland Stage Company, You can mail your dues to The Loveland Stage Company, PO Box 312, Loveland OH 45140. They must be received by May 18th to vote in the election.
- 4) **Code of Conduct** LSC has adapted a code of conduct for all members and our group as a whole.
- 5) **ACT Annual Awards** Carissa Sloan will discuss ACT awards in general and the "Big Three" annual lifetime awards from ACT and nominations for these awards. A description of each of the big three awards can be found on the following page. We will also ask volunteers to write the nominations for these awards as well as submitting them.



The Mario Pitocco Award

Established in 1988

To preserve and encourage innovative technical theatre in memory of *Mario Pitocco*, this award is presented annually to honor an individual who has shown continuous service and excellence in creative technical theatre, including, but not limited to: costuming, house management lighting sound program, props, set décor, set design, set construction, stage management, etc.

The Art Rouse Award

Established in 1976

ACT of Greater Cincinnati presents the prestigious Art Rouse Award to an ACT theatre member who has shown exceptional commitments and dedication to community theatre. Art served as president of ACT of Greater Cincinnati, Inc., establishing the annual President's Award, and was a tireless and capable administrator. He was an OCTA delegate, and worked both on and off stage for numerous groups. This award is given in memory of Art and his efforts to promote community theatre and improve its quality.

The Roger Grooms Award

Established in 2007

Known for his wit, eloquence, charm and passion for theatre, Roger Grooms supported the artistic growth of theatre in our region throughout his long career as an educator, film and dramatic critic, actor and director of plays and musicals. This award is therefore given annually in Roger's memory to honor an individual who has demonstrated dedication to raising the artistic quality of community theater production through active teaching and/or by demonstrating sustained excellence in the categories of directing, acting, choreography, musical or vocal direction.

CALL FOR DIRECTORS

THREE STEP PROCEDURE FOR SUBMITTING A PLAY FOR PRODUCTION AT LOVELAND STAGE CO.

Step One: The director will submit in writing, a short (60 words or less), summary of the action of the play or musical. Following the summary, the director will describe his or her background in the theater and explain their unique qualifications for directing their play. *Proposals for the coming season (June 1, 2021 thru May 31, 2022) must be submitted in writing to the board by May 31, 2021 to be assured consideration for the season.*

Step Two: If the director's proposal is approved, the director will complete a detailed production plan and submit the plan to the board, in person, for their approval. An example of a production plan is as follows:

List all the characters in the play or musical and give a brief description of their age and type.

What is your overall concept of the play?

Describe your vision of the set and costumes.

How much rehearsal time will you need for this play?

Will you need extra production assistants, e.g. assistant director, assistant music director, vocal coach?

Do you have a proposed budget for the production?

Are there any exception costs associated with this production? (orchestra or musicians, etc.)

Do you have scheduling concerns regarding your availability? In other words, when would you be available to direct this production?

The board will consider the plan and suggest possible revisions to the play.

Step Three: Revisions may be made to the plan and the board makes a final determination regarding the play/musical.
